Commitment to achieving Net Zero

Invitise Ltd remains committed to achieving Net Zero emissions by 2030. Over the past year, we have continued to reduce our carbon footprint, with measurable reductions across Scope 2 and Scope 3 emissions. Our permanent Work from Home model has been a major contributor, eliminating commuting emissions and lowering office energy usage.

Emissions reduction targets

Over the past year, we have made significant progress in reducing our carbon emissions. Our total emissions have decreased from 4.5 tCO₂e in the previous reporting year to 3.6 tCO₂e in the current reporting year, representing a 20% reduction. We have now achieved a 40% reduction since the baseline year. We have set a target to reduce our emissions to below 3.0 tCO₂e by September 2026, representing a 50% reduction compared to the baseline.

Carbon Reduction Initiatives

Progress Update (September 2024 – September 2025)

Energy Efficiency & Renewables:

- Transitioned to 75% renewable electricity, with full transition planned for 2026.
- Reduced electricity use through smart thermostats and energy-efficient IT hardware.

Work from Home & Sustainable Transportation:

- Maintained Work from Home as default, eliminating commuting emissions completely.
- Reduced business travel emissions by 22% compared to last year through expanded use of virtual meetings.

Waste Reduction and Recycling:

- Increased recycling rate, reducing waste emissions from 0.8 tCO₂e to 0.6 tCO₂e.
- Introduced a paperless workflow policy, reducing paper usage by 60%.

Sustainable Procurement:

- Achieved 60% of office supplies sourced from environmentally sustainable suppliers.
- Embedded lifecycle assessments in procurement decisions.

Employee Engagement:

- Launched monthly sustainability updates and employee-led green challenges.
- Staff-led initiatives delivered new energy savings.

Carbon Offsetting:

 Invested in verified offset projects covering 1 tCO₂e of residual emissions.

Future Initiatives (2025 - 2026)

Expand Renewable Energy Usage:

 Maintain renewable energy usage where available and explore opportunities to increase the share of renewables in our supply.

Strengthen Waste Management:

 Continue reducing operational waste by improving recycling and minimising paper use.

Increase Sustainable Procurement:

 Aim to gradually increase the proportion of office supplies sourced from environmentally sustainable suppliers.

Employee Engagement:

 Continue staff-led sustainability challenges and awareness activities to support ongoing carbon reduction efforts.

Client Meetings and Travel:

 Maintain a virtual-first approach for client meetings, limiting in-person travel to essential situations only.
